

RESOLUTION NO. R17-08

RESOLUTION ADOPTING THE UPDATED LAKE COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN AND DECLARING AN EMERGENCY

WHEREAS, natural, technological, and man-made hazards can affect North Perry Village; and

WHEREAS, significant structural, historical, and economic losses could result from an occurrence of a natural, technological, or man-made hazard events; and

WHEREAS, undertaking mitigation projects during pre-disaster periods could decrease the total losses North Perry Village incurs as a result of said hazard occurrences; and

WHEREAS, North Perry Village has partnered with Lake County to update the existing Lake County Multi-Jurisdictional Hazard Mitigation Plan, adopted in 2004, in an effort to further identify, define, and characterize the hazards affecting the Village; and

WHEREAS, North Perry Village has a strong interest in reducing losses from future hazard occurrences; and

WHEREAS, the hazard mitigation plan is a federal and state requirement to maintain eligibility for hazard mitigation funding, and, by that requirement, must be updated a minimum of every five (5) years; and

WHEREAS, a cooperative, joint effort is a proven, efficient way to plan for and reduce hazard susceptibility in all government jurisdictions in Lake County, Ohio.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NORTH PERRY, COUNTY OF LAKE AND STATE OF OHIO, AS FOLLOWS:

SECTION 1. That North Perry Village Council does hereby adopt the updated Lake County Multi-Jurisdictional Hazard Mitigation Plan (as presented and with any federally-required modifications).

SECTION 2. That all formal actions of this Council concerning the passage of its Resolution were adopted in an open meeting, and all deliberations of this Council, or any of its Committees, which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the residents of the Village of North Perry, the emergency being the need to adopt the Updated Lake County Multi-Jurisdictional Hazard Mitigation Plan to ensure the inclusion of the Village of North Perry.

WHEREFORE, this Resolution shall be in full force and effect immediately upon its passage by Council.
