

ORDINANCE NO. 16-14

ORDINANCE AMENDING SECTION 113.01 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF NORTH PERRY RELATING TO POSTING PLACES AND DECLARING AN EMERGENCY

WHEREAS, the Village of North Perry has determined that it is desirable and necessary to amend Section 113.01 of the Codified Ordinances relating to Posting Places.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NORTH PERRY VILLAGE, COUNTY OF LAKE AND STATE OF OHIO, AS FOLLOWS:

Section 1. Section 113.01 of the Codified Ordinances of the Village of North Perry is hereby amended to read as follows:

113.01 POSTING PLACES.

Council hereby declares from and after the effective date of this section that whenever ordinances, resolutions or other publications are required by law or ordinance to be published, and publishing may be accomplished by posting in not less than five of the most public places in the Village, for a period of not less than fifteen days prior to the effective date thereof, the five public places of posting shall be the Village Hall on Lockwood Road, the bulletin board at the North Townline Road Park, the website for North Perry Village, Champs Barber Shop and South Shores Controls. (Ord. 00-08. Passed 3-2-00.)

Section 2. Upon the effective date of this Ordinance, the Clerk of Council of the Village of North Perry, Ohio shall make available to all members of Council, and any members of the public, when required, copies of this amendment to the Codified Ordinances of the Village of North Perry, Ohio.

Section 3. The severability provisions of the Codified Ordinances Section 101.08 shall be applicable to this Ordinance.

Section 4. That all formal actions of this Council concerning the passage of this Ordinance were adopted in an open meeting, and all deliberations of this Council, or any of its committees, which result in formal actions, were in meeting open to the public, in compliance with all requirements included in Section 121.22 of the Ohio Revised Code.

Section 5. This Resolution is hereby declared to be and is passed as an emergency Resolution, the emergency being the necessity to timely amend the Ordinance regarding posting places. This Resolution is necessary for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village of North Perry.

WHEREFORE, this Resolution shall be in full force and effect immediately upon its passage by Council.
