

RESOLUTION NO. R17-02

A RESOLUTION AUTHORIZING THE APPOINTMENT OF DOLLIE SEESE AS THE VILLAGE SECRETARY – ADMINISTRATIVE ASSISTANT, A PART-TIME VILLAGE EMPLOYMENT POSITION, COMMENCING JANUARY 1, 2017, AT A RATE OF TWELVE DOLLARS (\$12.00) PER HOUR AND DECLARING AN EMERGENCY

WHEREAS, the Mayor for the Village of North Perry has recommended for approval the appointment of Dollie Seese as the Village Secretary – Administrative Assistant, a part-time Village employment position of approximately twenty (20) to twenty-five (25) hours per week, commencing January 1, 2017, at a compensation rate of Twelve Dollars (\$12.00) per hour; and

WHEREAS, the Village Council is desirous of approving said appointment.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NORTH PERRY, COUNTY OF LAKE AND STATE OF OHIO, AS FOLLOWS:

SECTION 1. The appointment of Dollie Seese as the Village Secretary – Administrative Assistant, a part-time Village employment position of approximately twenty (20) to twenty-five (25) hours per week, commencing January 1, 2017, at a compensation rate of Twelve Dollars (\$12.00) per hour, is hereby approved.

SECTION 2. That all formal actions of this Council concerning the passage of this Resolution were adopted in an open meeting, and all deliberations of this Council, or any of its Committees, which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. This Resolution is hereby declared to be and is passed as an emergency Resolution, the emergency being the necessity to fill the position of Village Secretary – Administrative Assistant. Said Resolution is necessary for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village of North Perry.

WHEREFORE, this Resolution shall be in full force and effect immediately upon its passage by Council.
