

# RESOLUTION NO. R17-16

**RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT AND AUTHORIZING THE FISCAL OFFICER TO ENCUMBER AND EXPEND ONE THOUSAND TWO HUNDRED SIXTY DOLLARS (\$1,260.00) TO CIRO'S SEWER CLEANING FOR STORM SEWER CLEANING ON EVERGREEN ROAD AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Village is desirous of storm sewer cleaning on Evergreen Road; and

**WHEREAS**, Ciro's Sewer Cleaning has submitted a bid for the cleaning of a 12" Storm Main on Evergreen Road in the amount of One Thousand Two Hundred Sixty Dollars (\$1,260.00), said quote being attached hereto and marked as Exhibit A.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NORTH PERRY, COUNTY OF LAKE AND STATE OF OHIO, AS FOLLOWS:**

**SECTION 1.** The Mayor is hereby authorized to enter into a contract with Ciro's Sewer Cleaning in the amount of One Thousand Two Hundred Sixty Dollars (\$1,260.00) for the storm sewer cleaning on Evergreen Road, pursuant to the terms set forth in Exhibit A.

**SECTION 2.** The Fiscal Officer is authorized to encumber and expend One Thousand Two Hundred Sixty Dollars (\$1,260.00) to Ciro's Sewer Cleaning for said project.

**SECTION 3.** That all formal actions of this Council concerning the passage of this Resolution were adopted in an open meeting, and all deliberations of this Council, or any of its Committees, which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4.** This Resolution is hereby declared to be and is passed as an emergency Resolution, the emergency being the immediate necessity to begin the project while weather permits. Said Resolution is necessary for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village of North Perry.

**WHEREFORE**, this Resolution shall be in full force and effect immediately upon its passage.
