

RESOLUTION NO. R17-26

A RESOLUTION APPOINTING CT CONSULTANTS, INC. AS ZONING INSPECTOR FOR THE VILLAGE OF NORTH PERRY PURSUANT TO THE SAME OR SIMILAR PROVISIONS AS SET FORTH IN THE ZONING INSPECTOR CONTRACT MARKED AS EXHIBIT "A," ATTACHED HERETO AND INCORPORATED HEREIN, AND AUTHORIZING THE MAYOR TO ENTER INTO SAID CONTRACT; FOR THE FISCAL OFFICER TO ENCUMBER AND EXPEND THE FUNDS NECESSARY TO ACCOMPLISH SAME; AND DECLARING AN EMERGENCY

WHEREAS, the Zoning Inspector shall be appointed by and serve at the pleasure of Council pursuant to the provisions of Section 1102.01 of the Codified Ordinances of North Perry, Ohio.

WHEREAS, the Village Council is desirous of making said appointment by naming CT Consultants, Inc. as the Village Zoning Inspector pursuant to the same or similar provisions as set forth in the Zoning Inspector Contract marked as Exhibit "A."

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NORTH PERRY, COUNTY OF LAKE AND STATE OF OHIO, AS FOLLOWS:


SECTION 1. That CT Consultants, Inc. is hereby appointed as the Zoning Inspector for the Village of North Perry, pursuant to the provisions of Exhibit "A" of this Resolution.

SECTION 2. That the Mayor is authorized to enter into a Contract with CT Consultant, Inc. pursuant to the same or similar provisions as set forth in Exhibit "A" of this Resolution, and the Fiscal Officer is authorized to encumber and expend the funds necessary to accomplish same.

SECTION 3. That all formal actions of this Council concerning the passage of this Resolution were adopted in an open meeting, and all deliberations of this Council, or any of its Committees, which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. This Resolution is hereby declared to be and is passed as an emergency Resolution, the emergency being the necessity to fill the position of Zoning Inspector. Said Resolution is necessary for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village of North Perry.

WHEREFORE, this Resolution shall be in full force and effect immediately upon its passage by Council.
